- 1 (a) At 20 December 2024, 43 members of the Rotary Club have paid their 2024/25 Presidential year membership subscriptions in full. - 1 (a) At 20 December 2024, the sum of £5,739.00 has been received from Rotarians on account of their future dining costs.
